- (i) The tentative cost of the said flat is fixed at **Rs.33,99,433/-**
- (ii) 25% of the tentative cost after deducting the EMD amount of Rs.1,00,000/- i.e., **Rs.7,49,858/-** should be paid on or before **03.04.2015**
- (iii) Remaining tentative cost of the flat should be remitted within one month from the date of receipt of demand from the Federation after the construction reaches the following stages:-
 - (a) 25% of tentative cost after casting of roof concrete for the ground floor
 - (b) 25% of tentative cost after the construction reaches lintel level for the second floor.
 - (c) 25% of the tentative cost after casting of roof concrete for the third floor

He is further informed that in case of the above said conditions are not fulfilled and if the amount as mentioned above, is not remitted within the stipulated time limit the allotment of flat will stand cancelled without any intimation and 1% of the tentative cost of the flat will be forfeited from EMD already paid by him.
