

# DECLARATION, SUPPORTED BY AN AFFIDAVIT, WHICH SHALL BE SIGHNED BY THE PROMOTER OR ANY PERSON AUTHORIZED BY THE PROMOTER

#### **Affidavit cum Declaration**

I, N.kandhapalanivel (Promoter of the project / duly authorised by the promoter of the project) do hereby solemnly declare, undertake and state as under:-

1. That (I/Promoter) (have / has) a legal title to the land on which the development of the project is proposed.

and

a legally valid authentication of title of such land along with an authenticated copy of the agreement between such owner and promoter for development of the real estate project is enclosed herewith.

- 2. That the said land is free from all encumbrances.
- 3. That the time period within which the period will be completed by (me/the promoter) is 3 Months.
- 4. That seventy per cent of the amounts realised by (me/the promoter) for the real estate project from the allottees, from time to time, will be deposited in a separate account to be maintained in a scheduled bank to cover the cost of construction and the land cost and will be used only for that purpose.
- 5. That the amounts from the separate account, to cover the cost of the project, will be withdrawn by (me/the promoter) in proportion to the percentage of completion of the project.

- 6. That the amounts from the separate account will be withdrawn by (me / the promoter) after it is certified by an engineer, an architect and a chartered accountant in practice that the withdrawal is in proportion to the percentage of completion of the project.
- 7. That (I / the promoter) will get the accounts audited within six months after the end of every financial year by a chartered accountant in practice, and will produce a statement of accounts duly certified and signed by such charted accountant and it will be verified during the audit that the amounts collected for a particular project have been utilised for the project and the withdrawal has been in compliance with the proportion to the percentage of completion of the project.
- 8. That (I / the promoter) will take all the pending approvals on time, from the competent authorities.
- 9. That (I/the promoter) (have / has) furnished such other documents as have been prescribed by the Act and the rules and regulations made thereunder.

10. That (I/the promoter) will not discriminate against any allotee at the time of allotment of any apartment, plot or building, as the case may be.
