

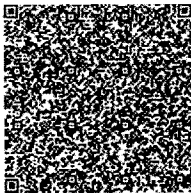

a legally valid authentication of title of such land along with an authentication copy of the agreement between such owner and promoter for development of the estate project is enclosed herewith.

2. That the said land is free from all encumbrances.

That details of encumbrances_____ including details of any rights, title, interest, dues, litigation and names of any party in or over such land.

3. That the time period within which the project will be completed by [me/the promoter] **Three Years.**
4. That seventy per cent of the amounts realised by [me/the promoter] for the real estate project from the allottees, from time to time, will be deposited in a separate account to be maintained in a scheduled bank to cover the cost of construction and the land cost and will be used only for that purpose.
5. That the amounts from the separate account, to cover the cost of the project, will be withdrawn by [me/the promoter] proportion to the percentage of completion of the project.

6. That the amounts from the separate account will be withdrawn by [me/the promoter] after it is certified by an engineer, an architect and a chartered accountant in practice that the withdrawn is n proportion to the percentage of completion of the project.
7. That [I/ the promoter] will get the accounts audited within six months after the end of every financial year by a chartered accountant in practice, and will produce a statement of accounts duly certified and signed by such chartered accountant to the Authority and it will be verified during the audit that the amounts collected for a particular project have been utilized for the project and the withdrawals has been made in compliance with the proportion to the percentage of completion of the project.
8. That [I/ the promoter] will take all the pending approvals on time, from the competent authorities.
9. That [I/ the promoter] [have/has] furnished such other documents as have been prescribed by the Act and the rules and regulations made there under.
10. That [I/ the promoter] will not discriminate against any allottee at the time of allotment of any apartment, plot or building, as the case may be.
