Suit filed by the Plaintiffs to declare that they are the only legal heirs of the deceased Peddireddy Sriramamurthy and Gangabhavani for cost.

The cause of action for the suit arose long back, when the marriage of the Peddireddy Sriramamurthy and Gangabhavani was

performed and During their lawful wedlock the they gave birth to 1st Plaintiffs herein on 20-02-1963 and birth to 2nd Plaintiffs herein on 15-08-1964. The mother of the Plaintiffs died intestate on 13.11.2008. The father of the Plaintiffs died intestate on 09.01.2019. And their death was duly registered in the Office of Registrar of Births and Deaths, Yanam. The Plaintiffs further submit that the 1st Plaintiff approached the 2nd Defendant on 25-01-2019 for issue of legal heirs certificate, the 2nd Defendant denied to issue.

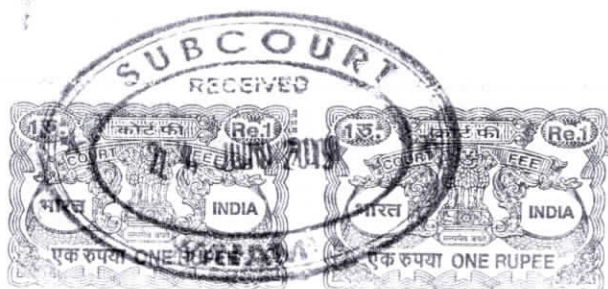
The Plaintiff valued the suit for the purpose of Court fees and jurisdiction at Rs.400/- and paid a court fee of Rs.30.50/- under section 25(d) of Pondicherry Court Fees and Suits Valuation Act.

This Suit was taken on file on 07.02.2019 and the same came up on 11.04.2019 for final hearing in the presence of Tvl. K.Vijaya Kumar, P.S.N.Raju, P.A.Murthy and Tmt. A.Usharani Counsel for the Plaintiffs and the Asst. Government Pleader for the Defendants, upon hearing both sides and perusing the case records, this Court delivered the following:

DECREE

This court doth Order and Decree:-

1. That the Suit be and the same is hereby decreed.



2. That the Plaintiffs are the only legal heirs of the deceased Peddireddy Sriramamurthy and Gandabhavani.
3. That there is no order as to costs.
