

- 4. That seventy per cent of the amounts realized by me for the real estate project from the allottees, from time to time, shall be deposited in a separate account to be maintained in a schedule bank to cover the cost of construction and the land cost and shall be used only for that purpose.
- 5. That the amounts from the separate account, to cover the cost of the project, shall be withdrawn in proportion to the percentage of completion of the project.

- 6. That the amounts from the separate account shall be withdrawn after it is certified by an engineer, an architect and a chartered accountant in practice that the withdrawal is in proportion to the percentage of completion of the project.
- 7. That I shall get the accounts audited year by a chartered accountant in practice, duly certified and signed by such chartered audit that the amounts collected for a project and the withdrawal has been percentage of completion of the project.
- 8. That I will take all the pending approvals on time, from the competent authorities.
- 9. That I have furnished such other documents as have been prescribed by the rules and regulations made under the Act.
- 10. That I will not discriminate against any allottee at the time of allotment of any apartment, plot or building, as the case may be, on any ground.
