

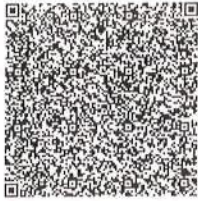

AFFIDAVIT CUM DECLARATION

Affidavit Cum Declaration of Thiru T. Murugan promoter of the proposed project / duly authorized by the promoter of the proposed project, vide its/his/their authorization dated 07.01.2022.

I **T. Murugan** promoter of the proposed project / duly authorized by the promoter of the proposed project do hereby solemnly declare, undertake and state as under:

1. That We have a legal title to the land on which the development of the project is proposed.

OR

I **T. Murugan** have a legal title to the land on which the development of the proposed project is to be carried out.

AND

a legally valid authentication of title of such land along with an authenticated copy of the agreement between such owner and promoter for development of the real estate project is enclosed herewith.

2. That the said land is free from all encumbrances.

OR

That details of encumbrances including details of any rights, title, interest or name of any party in or over such land, along with details.

3. That the time period within which the project shall be completed by me is THREE YEARS.

4. That seventy per cent of the amounts realized by me for the real estate project from the allottees, from time to time, shall be deposited in a separate account to be maintained in a schedule bank to cover the cost of construction and the land cost and shall be used only for that purpose.

5. That the amounts from the separate account, to cover the cost of the project, shall be withdrawn in proportion to the percentage of completion of the project.

6. That the amounts from the separate account shall be withdrawn after it is certified by an engineer, an architect and a chartered accountant in practice that the withdrawal is in proportion to the percentage of completion of the project.

7. That I shall get the accounts audited year by a chartered accountant in practice, duly certified and signed by such chartered audit that the amounts collected for a project and the withdrawal has been percentage of completion of the project.

8. That I will take all the pending approvals on time, from the competent authorities.

9. That I have furnished such other documents as have been prescribed by the rules and regulations made under the Act.

10. That I will not discriminate against any allottee at the time of allotment of any apartment, plot or building, as the case may be, on any ground.
