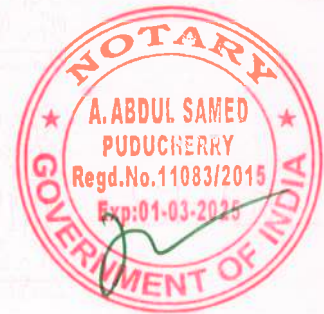

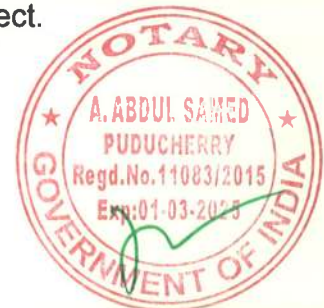
That details of encumbrances including details of any rights, title, interest or name of any party in or over such land, along with details.
