2. This registration is granted subject to the following conditions, namely:-
 - (i). The promoter shall enter into an agreement for sale with the allottees as prescribed in the Puducherry Real Estate (Regulation and Development) (Agreement for Sale) Rules, 2017.
 - (ii). The promoter shall execute and register a conveyance deed in favour of the allottee as per section 17 of the Real Estate (Regulation and Development) Act, 2016.
 - (iii). The promoter shall deposit seventy percent of the amounts realised by the promoter in a separate account to be maintained in a scheduled bank to cover the cost of construction and the land cost to be used only for that purpose as per sub-clause (D) of clause (l) of sub-section (2) of section 4 of the Real Estate (Regulation and Development) Act, 2016.
 - (iv). The registration shall be valid for a period of three year commencing from 30.12.2021 and ending with 29.12.2024 unless extended by the Authority in accordance with the Real Estate (Regulation and Development) Act, 2016 and the Puducherry Real Estate (Regulation and Development) (Agreement for Sale) Rules, 2017 made thereunder;
