Affidavit cum Declaration

We, **S. Rajkumar & C. Sakthivel**, promoter of the project "**SRI SIVASAKTHI NAGAR**" at R.S. Nos. 34/2APT & 34/2BPT, Kothapurinatham, Thiruvandarkoil Revenue Village, Mannadipet Commune, Puducherry do hereby solemnly declare, undertake and state as under:-

1. That (1) Thiru. K. Thulasingham (2) Thiru. J. Janarthanan, (3) Thiru. J. That We will get the accounts audited within six months after the end of every financial year by a chartered accountant in practice, and will produce a statement of accounts duly certified and signed by such chartered accountant and it will be verified during the audit that the amounts collected for a particular project have been utilised for the project and the withdrawal has been in compliance with the proportion to the percentage of completion of the project.
8. That we will take all the pending approvals on time, from the competent authorities.
9. That we have furnished such other documents as have been prescribed by the Act and the rules and regulations made thereunder.
10. That we will not discriminate against any allottee at the time of allotment of any apartment, plot or building, as the case may be.
