- I, **K. Dinesh Kumar**, promoter of the project **"GREEN CITY"** at R.S. Nos. 6PT, 8 & 10, Koodapakkam Revenue Village, Villianur Commune, Puducherry do hereby solemnly declare, undertake and state as under:-
- 1. That (1) Thiru. A. Kamaleshkumar and (2) Thiru. A. Aravindkumar have a legal title to the land on which the development of the project is proposed and a legally valid Power of Attorney on such land between the owner and the promoters of the project for sale of land / development of a real estate project has been obtained by the promoters.
- 2. That the said land is free from all encumbrances.
- 3. That the time period within which the project will be completed by me is 60 Months.
- 4. That seventy per cent of the amounts realised by me for the real estate project from the allottees, from time to time, will be deposited in a separate account to be maintained in a scheduled bank to cover the cost of construction and the land cost and will be used only for that purpose.

That I will get the accounts audited within six months after the end of every financial year by a chartered accountant in practice, and will produce a statement of accounts duly certified and signed by such chartered accountant and it will be verified during the audit that the amounts collected for a particular project have been utilised for the project and the withdrawal has been in compliance with the proportion to the percentage of completion of the project.
- 8. That I will take all the pending approvals on time, from the competent authorities.
- 9. That I have furnished such other documents as have been prescribed by the Act and the rules and regulations made thereunder.
- 10. That I will not discriminate against any allottee at the time of allotment of any apartment, plot or building, as the case may be.
