

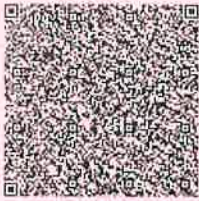


Affidavit cum Declaration

I, 1.A.THANIGAIVEL & 2.T.BHUVANESWARI, promoters of the project "ANNAI NAGAR" at R.S. No. 62/4, Plot No.1,2,3,4, Pillaichavady Revenue Village, Oulgaret Municipality, Puducherry do hereby solemnly declare, undertake and state as under:-

1. That the said land is free from all encumbrances.

That I will get the accounts audited within six months after the end of every financial year by a chartered accountant in practice, and will produce a statement of accounts duly certified and signed by such chartered accountant and it will be verified during the audit that the amounts collected for a particular project have been utilised for the project and the withdrawal has been in compliance with the proportion to the percentage of completion of the project.
7. That I will take all the pending approvals on time, from the competent authorities.
8. That I have furnished such other documents as have been prescribed by the Act and the rules and regulations made thereunder.


