- 7. That I will take all the pending approvals on time, from the competent authorities.
- 8. That Ihavefurnished such other documents as have been prescribed by the Act and the rules and regulations made thereunder.
- 9. That Iwill not discriminate against any allottee at the time of allotment of any apartment, plot or building, as the case may be.
