2. The Layout Promoter/Owners shall not encroach any Government land/canal/road portion adjoining or passing through the layout in any manner.
3. EWS plots as earmarked in the layout shall comply as per G.O.Ms.No.5/2015-Hg dt:26.02.2015 (copy enclosed).
4. The plots earmarked for "public purpose/public departments in the layout shall not to be sold to any individual within one year as per clause 8 of Annexure -II of Puducherry Building Bye Laws and Zoning Regulations, 2012.
5. The Layout Promoter/Owner shall settle any legal disputes in the Court of law in respect of the title deed and the Puducherry Planning Authority shall be indemnified.
6. The layout approval will be revoked if the same has been obtained by furnishing any false information/ statement /suppression of facts or misrepresentation of material facts.
7. The layout has to be registered with the Puducherry Real Estate Regulating Authority as per the section 3 of the Real Estate (Regulation and Development) Act, 2016.

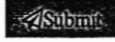
